ORDER NO. 4: SETTING TARGET DATE

(February 6, 2013)

On January 30, 2013, the Commission issued a Notice of Investigation in this matter to determine:

[W]hether there is a violation of subsection (a)(1)(B) of section 337 in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain wireless devices with 3G and/or 4G capabilities and components thereof by reason of infringement of one or more of claims 1, 3, and 6-12 of [U.S. Patent No. 7,190,966¹]; claims 1-3 and 5-11 of [U.S. Patent No. 7,286,847]; claims 1-18 of [U.S. Patent No. 7,616,970]; claims 1-6, 8, 9, 16-21, 23, and 24 of [U.S. Patent No. 7,941,151]; claims 1-3, 5-8, 10, 16-18, 20-23, and 25 of [U.S. Patent No. 7,706,830]; claims 1-4, 6-9, and 29-31 of [U.S. Patent No. 8,009,636]; and claims 1, 2, 6-9, 13, 15, 16, 20-22, 26, 28-30, 34-36 and 40 of [U.S. Patent No. 7,502,406] and whether an industry in the United States exists as required by subsection (a)(2) of section 337.

(See Notice of Investigation.) The investigation was instituted upon publication of the Notice of Investigation in the *Federal Register* on February 5, 2013. See 78 Fed. Reg. 8191-92 (2013); 19 CFR § 210.10(b).
