On December 3, 2013, Complainant filed a motion to terminate based on a withdrawal of the Complaint. It is the Administrative Law Judge's understanding that Respondents need time to evaluate the motion, but that the parties do not want to proceed with the pre-hearing conference and evidentiary hearing tomorrow.
